

## THE VESTRY AND ANNUAL CHURCH MEETING

The Vicar spoke highly of the excellent work of the Churchwardens, and their meticulous attention to their duties. After Mr. W. F. Wigginton had been nominated by the Vicar, and confirmed in his appointment by unanimous vote of the whole meeting, the Vicar went on to say:—

“As members of the Church Council know—and the news has perhaps spread further — Mr. Western feels constrained not to offer himself for re-election. The decision has not been an easy one for him to make, or for us to accept, but we understand and appreciate the motives that have led him to decide in this way. On various good grounds he feels he can no longer do full justice to the heavy demands of this office, and as he is one who cannot do anything he undertakes half-heartedly or giving less than his best, he feels it is now time for him to withdraw. He has served for three years without sparing himself, he has set himself the highest standards, and been utterly conscientious in fulfilling them. He has made himself a friend to all, and his wise counsel has been of the greatest possible help to me personally, as well as to the Standing Committee and the whole Council. It is with deep regret and heartfelt gratitude that I face his relinquishment of office, and I am sure that you all feel the same; and therefore, before we pass on to the nomination of a successor, I should like to move from the chair, as an inadequate token of our affection for him and our appreciation of his great services, a hearty vote of thanks.” This was carried with enthusiasm: and then immediately we were in difficulties! The Meeting found it impossible to make a nomination, and accordingly had to be adjourned until after the evening Service on Low Sunday.

The substance of the Vicar's report, and a summary of the accounts and elections, will be given in next month's magazine. The

first part of the report presented by Mr. Forrow on the work of the Church Council since the last Annual Meeting follows:—

## THE SECRETARY'S REPORT

Your Council has met nine times during the year under review, including an adjourned meeting. At its first meeting, the Council elected the usual Officers and Committees, and also set up three Commissions on Worship, Education and “The Wider Church.” The Committees and the Commissions have met frequently and in general, the Council has had a very active year. In the knowledge of the extra calls which would be made upon the time of the Council Members sitting on the Commissions, the Council rescinded its previous decision that the Council should meet monthly.

The Council were sorry to lose the services of Miss O. Chamberlin by reason of her leaving the district.

The work of repairing the church has proceeded during the year under the Council through the Renovation Fund Committee. The main work has been the restoration of the beams in the north and south aisles and the making waterproof of the roof. The matter of curing the rising damp in the tower has been postponed and consideration given to the repair and redecoration of the inside of the tower, including the grills. It is hoped that this work will be completed by the summer, to admit of the church clock's being repaired, cleaned and repainted in the autumn of 1955. During the year, members of the Church organised functions at their homes for raising funds for the renovation work and an “At Home” and a Flower Show were also held for this purpose.

Under the guidance of the Council, the Parish News-Team set up a Street Wardens' Service, which is in operation in nearly every street of the parish and is linked up with the Hampton Hill Old People's Welfare Committee.

The Council has occupied itself extensively in the work of the three Commissions previously referred to and whose activities during the year are summarised as follows:—

### **Commission on Worship:**

Introduction of a Parish Communion in place of the Sung Eucharist.

Congregational practices with the object of improving the congregational singing and giving people the opportunity to learn the Merbecke settings, and new chants and tunes.

Encouragement of Baptisms at Morning or Evening Prayer.

Abolition of pew rents (this was put into effect from 31.12.54).

Provision of new hassocks.

Suggestion that congregation sit near front of church.

Congregation to stand at same time as the choir.

Provision of the shorter form of the Prayer Book.

Clearance of old and useless books, etc., from the church and a special cleaning.

The omission of the hymn before the General Confession during Lent.

Altar Servers to be obtained from the Youth Fellowship.

### **Commission on Education:**

The work of this Commission has been largely exploratory — gathering information about the various activities of educational value in the Parish and seeing how far assistance was needed. The Sunday Schools and the Youth Organisations have been specially under review. The need for more properly instructed Sunday School teachers has emerged.

### **Commission on "The Wider Church":**

This Commission has concerned itself with the formation of a Parish Voluntary Service and a Church Badminton Club and with the calling of a meeting of representatives of churches, statutory and other bodies in Hampton Hill, from which an Old People's Welfare Committee has been set up and on which the Church and Council are represented. A special Service of Praise was arranged

for the old folk. The work of the Commission proceeds.

The Council have been mindful of the need, since the sale of the Club Rooms, for accommodation, preferably adjacent to the church, for parochial organisations. With this in view, the Council has, through the London Diocesan Fund, purchased the freehold property, Wayside, No. 7, Saint James's Road, Hampton Hill, for parochial use in so far as the ground-floor rooms are concerned and by way of providing an income, the letting of the upstairs rooms following their conversion into three flats (furnished). The suggestion that members of the church be invited to make loans of £25 (free of interest) to assist with the capital payment, is passed to the annual meeting. The land in School Road, which was purchased for a proposed new hall, is now for sale.

The Council are pleased to report that they have been able to continue their unbroken record of paying their full Quota to the London Diocesan Fund, and have also organised the People's Offering on behalf of Moral Welfare.

## "ADVENTURES BY LAND AND SEA"

### In this Mid-Twentieth Century

Come and see the Exhibition—maybe you will find out that you have a part in this great adventure. Maybe you can have some share in moulding

the World in this mid-twentieth century, and so prevent the World drifting on to troublous times. So please book the dates — **26th to 28th April**, and come along—bring a friend, preferably someone who is not interested in Church. There will be exhibits of great interest for all to see—films—talks—and above all—good fellowship.
